Many find these meetings help them to heal; and together we learn to live with our loss. We learn that ***we need not walk alone***.







TCF CANDLELIGHT MEMORIAL


Now is the time to be thinking about submitting your photos and dedications for our annual TCF Candlelight Memorial on December 13th.

We would like to introduce you to the people “behind the scenes” at the Pikes Peak Chapter of TCF. In the following months, we will try to spotlight a member of the Steering Committee, giving you the opportunity to put a face to a name.



Jane and Steve Gabriel came to Compassionate Friends in September 1991, 2 months after their son Jonathan died of leukemia at the age of 5. When the Steering Committee was formed 16 years ago, they were asked to be members. They agreed...and have been serving the Pikes Peak TCF Chapter ever since! Currently, Steve maintains the database for our Chapter, keeping parent contact info up-to-date, child birthday and anniversary dates accurate, and running labels for the few newsletters that we still mail out.

Jane enjoys doing Chapter outreach as a Steering Committee member, but her main job has been readying the mailing labels and coordinating the preparation of each month's 350+ newsletter mailing. Now that we have gone electronic with our newsletter, the monthly mailings will take much less time, and Jane can transition into another job on the Committee. She's looking forward to that, as she has been mailing coordinator for 12+ years!

“In addition to being on the Steering Committee, we try to facilitate one Chapter meeting a year and to be on hand for most of the adjunct Chapter events. These volunteer activities and our service on the Steering Committee are done in loving memory of our sweet Jonathan and as a way to “pay it forward.” People were there to help us when we were newly bereaved...now it's our turn to reach out and do the same for other bereaved parents.”

The Gabriels live in Briargate with their dog Bailey and occasionally Jonathan's younger brother Jason, who is 20 and a junior in college in Massachusetts.

In Response to a message "One Balloon."

I too, have wondered who finds the balloons we send to our children. We released balloons last year for Melanie's first birthday in Heaven. But this year, being her 21st birthday we, Melanie's best friend Lisa and I, wanted to do something special to honor her. So, like last year we sent up balloons but I borrowed an idea from another parent. Each balloon carried inside Forget-Me-Not flower seeds. I like to think that when the balloons burst that the seeds dropped to earth and Forget-Me-Not flowers will soon grow in memory of Melanie.

Then I remembered something that my oldest daughter had done when she was in the 2nd grade. Her class had a balloon send off with notes attached. The notes asked the person, who found the balloon, to please send it back to the student. The school wanted to see how far the balloons would travel and how many they would get back. I don't know how many were found, but about a year and a half later Trinity's was returned. It had been found by a farmer plowing his field.

So we attached notes, with a return address label, to each of the balloons. I was eager to find out if anyone would find one of our balloons.

About a week later, I received one of the balloons in the mail. It had been found the next day in a neighboring state. A bank president found it in his parking space. At first he said he thought it was just trash but discovered it was my balloon. He took the time out to mail, even the balloon, back to me with a very nice letter. He wrote that he took the note into the bank and shared the message with his co-workers. He said after reading the note that there wasn't a dry eye left in the house. That everyone had been moved by the message and what it stood for. He had just recently lost his father and was dealing with his own pain and grief. He said he had a young daughter and understood some of what I was feeling. So I hope in some small way that finding Melanie's message might have brought him some- small- comfort. But our loss and our pain are not that different, for through the death of our children, we have lost the same thing: dreams of the future. Yes, you have more memories than I, but we have both lost the tomorrows of our children, and that pain knows no minimum age. God, it hurts. All of the things we've wished for our child, with no regard to age, now will not come to pass; that future is gone. Yes, my son was an infant, but that does not lessen the love that I have, as the age of your child does not affect your love. Love is an ageless emotion. And when my young son died, he carried away in his little hands as many dreams, hopes, and love as your child did when he left. I miss you Alex.

Identity theft can victimize the dead

Identity thieves can strike even after death. An identity thief's use of a deceased person's Social Security number may create problems for family members. This type of identity theft also victimizes merchants, banks, and other businesses that provide goods and services to the thief.

What happens to your Social Security number after you die? The Social Security Administration (SSA) maintains a national file of reported deaths for the purpose of paying appropriate benefits. The file contains the following information: Social Security number, name, date of birth, date of death, state of last known residence, and zip code of last lump sum payment.

The SSA generally receives reports of death from a family member or a funeral home. Sometimes delays in reporting can provide time for identity thieves to collect enough personal information to open credit accounts or take other fraudulent actions using the deceased's information. To prevent this from happening, a surviving spouse or other authorized individual, such as an executor, can notify the credit bureaus. This will ensure that the deceased's files are flagged with a "deceased" notation.

Signs of possible identity theft include calls from a creditor or collection agency on an account opened or used in the deceased's name after death. If you discover such signs, contact the affected creditor or collection agency in writing, explaining that the account was opened or used fraudulently.

Notifying the Social Security Administration

In most cases, a funeral director will report the person's death to SSA. To ensure the death is reported promptly, a family member can make a report directly to an SSA representative by calling SSA toll-free, 1-800-772-1213 (TTY 1-800-325-0778), between the hours of 7:00 a.m. and 7:00 p.m. Monday through Friday. For more information, visit SSA online at www.ssa.gov/ww&os1.htm.

Notifying the credit bureaus

To flag the credit files of a person who is deceased, the surviving spouse or executor needs to notify the three national credit bureaus in writing. The surviving spouse or executor must include the following specific information along with the alert request: 1) a copy of death certificate, and 2) proof of executorship or marriage. Then mail the notification documents to the credit bureaus.
